Call To Order, Roll Call: The meeting of September 18, 2019, was called to order at 6:35 p.m. in the Library's Small Meeting Room at 15025 S. Illinois Street. Roll call was conducted. Trustee Attendance at Community Events: Trustees discussed attendance at various events including a Zonta meeting and Plainfield Area Chamber of Commerce luncheon. Joliet Junior College held a reception in recognition of Family Literacy Grant from the Secretary of State to expand services for families in English as a Second Language classes to be performed in partnership with Plainfield Public Library. The Friends of the Library: Tom Hernandez donated \$200.00 raised from his book reading at the Library. The Friends will have a fundraising event at restaurant Crave at 24020 W 119th St, Plainfield on October 2, 2019 from 7:00 a.m. to 9:00 p.m.

The Vox Books collection, started by the Library trustees in honor of Sharon Kinley, are already popular.
