SECTION 2. As part of the Annual Budget, it is stated:

a. The cash on hand at the beginning of the fiscal year is \$1,900,000.

b. The estimated cash expected to be received during the fiscal year from all sources is \$4,500,000.

c. The estimated expenditures for the fiscal year are \$4,400,000.

d. The estimated cash expected to be on hand at the end of the fiscal year is \$2,000,000.

e. The estimated amount of taxes to be received during the fiscal year is \$4,300,000.

f. The estimated amount of income to be received from sources other than library taxes for the fiscal year is \$200,000.

<u>SECTION 3</u>. Funds in the total amount of \$9,651,000 or so much thereof as may be authorized by law, be and the same are hereby appropriated as specified.

<u>SECTION 4</u>. All unexpended balances of proceeds received annually from public library taxes not in excess of statutory limits may be transferred to the Special Reserve Fund.
